Compare and contrast nonprofit management versus business management.

**Suggested answer:** Sample response: Nonprofit and business management are the same in that they both must be concerned about meeting the organizational mission and ensuring adequate revenue resources are available. The two management practices are different in that nonprofit managers are also reliant on the support of donors and the work of volunteers, whereas business management does not. Nonprofit managers are driven by mission rather than profits.

What is the difference between a for-profit business providing a service to its customers and a nonprofit providing a service to its customers?

**Suggested answer:** Sample response: When a business provides a service to its customers, it increases its resources, including its financial resources. However, when a nonprofit provides services, their resources are drained.

In your opinion, do managers of nonprofit organizations manage using a double bottom line or a triple bottom line? Explain.

**Suggested answer:** Sample response: I believe managers of nonprofit organizations must use the double bottom line of (1) meeting the organizations' social mission and (2) maintaining a financial bottom line to ensure organizational survival. I believe the suggested third bottom line, "the organization's impact on the environment," is subject to the nonprofit's purpose.

**Suggested answer:** Sample response: Dees and Anderson use the term to mean the same thing as "social innovation." Others use the term to refer to the application of business principles to revenue generation to nonprofits or creating for-profits with a social purpose.

**Suggested answer:** Sample response: The nonprofit management revolution occurred due to changes in funding patterns, growth in the sector, and increasing demands for accountability.

**Suggested answer:** Sample response: The authors of the article are concerned that traditional grant-making practices do not meet the long-term capacity needs of nonprofit organizations.

Determine the type of organization—a business or a nonprofit—where success is more difficult to come by. Why?

**Suggested answer:** Sample response: Success is more difficult to achieve when managing nonprofit organizations. Nonprofit chief executive officers (CEOs) must deal with more ambiguity than business managers. For example, business managers usually have clearly established goals and objectives set by paid corporate directors who share the same goals, values, and differing reasons for serving. Nonprofit CEOs work with volunteer directors who are likely to have different values, ethics, and agendas, and the CEO needs to be highly skilled in achieving consensus among these differing perspectives. Finally, business managers are ultimately responsible for ensuring the organization is profitable so dividends can be distributed to their shareholders. The ultimate responsibility for nonprofit managers is to ensure the organizational mission to serve a social purpose is achieved.

Should nonprofit management programs be taught in business schools, schools of public affairs and administration, or in colleges of arts and sciences? Defend your answer.

**Suggested answer:** *Sample response: I believe nonprofit programs are best taught in the schools of public affairs and administration. I choose this discipline because the field of public affairs and administration more broadly covers topic areas involving nonprofit organizations than do business schools and colleges of arts and sciences. For example, nonprofit curricula must include studies related to understanding political processes and how public policies are developed. Also, nonprofit managers must know how to apply government budgeting principles, implement public policies, and create community organizations. These are essential topics nonprofit managers need to understand in order to achieve their purposes to serve social needs.*

In your opinion, why must managers of nonprofit organizations be especially skilled in negotiation and compromise?

**Suggested answer:** *Sample response: I believe managers must be highly skilled in negotiation and compromise because managers of nonprofit organizations work in highly variable internal and external environments. Internally, the boards of directors, paid staff, volunteers, and clients are becoming increasingly sophisticated in their understandings of what types of work nonprofits should be doing, the need for flexible types of organizational structures, and what types of incentives they can be offered. Externally, the federal, state, local governments, and fundraising organizations are exerting more demands for financial accountability, and competing nonprofits strain available revenue streams.*
