**Q38. [Essay]**

Define the concept of self-fulfilling prophecy, and provide an example of its functionality.

**Suggested answer:** Sample response: The self-fulfilling prophecy is a social process where a false definition of a situation brings behavior that makes the false definition "true." For example, a 5-year-old boy who has a father imprisoned in the criminal justice system could be told by his mother that he looks just like his father and she cannot stand to look at him because she is afraid he will end up just like him. Then, that boy goes to school and his teachers also told him he is going to end up in prison like his father and they do not expect much from him. In turn, the boy starts to engage in delinquent behaviors and ends up in the criminal justice system. The socialization of his mother and teachers brought a pattern of behavior that made the false definition of him true by him ending up in the criminal justice system as predicted. Answers may vary based on the example chosen.

Describe the patterns of behavior that followed the pandemic caused by COVID-19 (coronavirus disease).

**Suggested answer:** Sample response: COVID-19 (coronavirus disease) was first reported in 2019 from China. Many governments responded with required guidelines for the behavior of their citizens including quarantines, nationwide lockdowns, mandatory closures of thousands of schools and businesses, and specific individual behaviors such as face masks and social distancing. These patterns of behavior were caused by the social problem of a rapidly spreading disease that caused a series of events that continue to impact our lives.

**Q40. [Essay]**

Explain how anomic suicide can help us understand the relationship between unemployment rates and men's suicide rates.

**Suggested answer:** Sample response: Emile Durkheim conducted a classical study on the social problem of suicide that concluded with the understanding that group differences are determined by social integration and social regulation levels. This led to the determination of four types of social suicide. In this question, anomic suicide is the result of too little social regulation leading to the absence of social norms. For example, the relationship between unemployment rates and men's suicide rates can be explained by understanding that when men lose their jobs, the societal norm of being the breadwinner is disrupted, causing an increase in suicide as they no longer are the productive, masculine person in the family.

**Suggested answer:** Sample response: Interviewing is the form of data collection where researchers ask their respondents a series of questions. Interview data can be collected via face to face or on the phone for a variety of social problems. The researcher records the subject's responses in writing or audio format by allowing the subject to speak freely and at length for each question. When data collection is complete, the researcher then listens back to the recordings and reviews their notes to identify categories and themes across all the subjects in the study.

**Suggested answer:** Sample response: George Herbert Mead was interested in understanding the relationship between mind, self, and society. His contributions to the field of sociology led to the creation of the symbolic interactionism theoretical perspective. The mind is the internal conversation we have with ourselves. For example, you may have an internal conversation by interpreting language and symbols without ever saying a word or feeling it consciously. The self is the process we go through to see ourselves in relationship to other people in the social world. We have to develop this social self over time through interactions with other people to fully understand where we "fit." Charles Horton Cooley took the ideas of the mind and self as they are related to society from George Herbert Mead and furthered them by proposing the concept of the looking-glass self or the idea that we see ourselves as we think others see us.

Describe the benefits of employing a mixed methods approach to research instead of using only a quantitative or qualitative method. Provide an example of when this research method might be more useful than one of the other two methods.

**Suggested answer:** Sample response: A mixed methodology has advantages over solely quantitative or qualitative research methods because combining methods often achieves a fuller picture of the social problem. For example, when exploring the everyday lives of families who immigrate to the United States from Mexico, a social scientist might rely on statistical analysis of immigrant data and interviews with family members about their experiences immigrating to another country. In this case, a researcher can understand the personal experiences of the immigrants and get a sense of who they are rather than just how many there are. Answers may vary based on the example provided.

Discuss how government implementation of social policy in the form of legislation made racial segregation illegal in the United States.

**Suggested answer:** Sample response: Government implementation of social policy in the form of legislation clearly articulates a condition or pattern of behavior that is legal or illegal. The Civil Rights Act of 1964 was a piece of legislation signed into law by President Lyndon B. Johnson to make racial segregation in public illegal in the United States. This led to guidelines demonstrated in the form of handbooks, manuals, and eventually today electronic methods that taught organizations what should and should not be acceptable behaviors in workplaces for racial segregation.

Evaluate how the phrase “social problems” has been defined by sociologists throughout history.

**Suggested answer:** Sample response: The phrase “social problems” has had a long history with social scientists. For most of the 19th century, the term referred to issues of unequal distribution of wealth. However, by the end of the 19th century, the phrase became framed as more of a social question that aided in determining sociology as a legitimate discipline. By the 1920s, the phrase “social problems” had been used to explain overpopulation, poverty, unemployment, labor conflicts, child labor, racism, crime, and juvenile delinquency. From the 1930s through the 1970s, the term “social problems” saw various definitions from state of mind versus value judgments to individual diagnoses. By 1987, the focus on social problems as subjective, constructionist, and claims-making had become the generally accepted perspective. The constructionist perspective, as it is known today, involves the process of claims-making or understanding individuals and groups through providing corrective conditions to the ills of society. A social problem is anything the public identifies as something that needs to be solved.

Explain the efforts of Jane Addams and the famous settlement house, Hull House, in one of Chicago's poorest neighborhoods in the 19th century.

**Suggested answer:** Sample response: Service sociology, public sociology, or activist research is meant to make sure that academics and universities serve the public. Jane Addams founded one of the most famous settlement houses in the 19th century called Hull House. Hull House was located in one of Chicago's poorest neighborhoods and had the goal of gathering empirical data on social problems affecting those living in groups in poverty. Throughout this research, Hull House also provided community services in the form of securing support for deserted women, conducting kindergarten and day nursery programs, implementing social programs for neighborhood improvement, and establishing a relief station.

**Suggested answer:** Sample response: Intersectionality is the way demographic factors combine to affect people's experiences. For example, if you are studying sexism in the workplace, you must account for race and ethnicity since White women's experiences differ from women of color. Age and social class may also shape women's experiences in the workplace. Answers will vary based on the example; however, age, ethnicity, gender, and social class are all common intersectionality principles that should be highlighted. Demographic factors combine to create unique experiences. Therefore, a true understanding of social problems requires an intersectional approach.
