Nurses also provide education on disease prevention strategies such as immunizations, screenings, and other healthy behaviors. In addition, they collaborate with individuals, families, and communities to develop personalized prevention plans and support patients in making informed choices to promote well-being. Through illness prevention, nurses contribute to reducing the incidence of preventable diseases and improving overall population health.

With autonomy, nurses support patients in making informed choices while considering their values, beliefs, and capacity to understand. By respecting the patient's confidentiality and not telling his family about his diagnosis, Marcel is using the ethical principle of fidelity, which is demonstrating faithfulness, loyalty, and commitment to patients. With fidelity, nurses establish trusting relationships, maintain confidentiality, and uphold professional standards to ensure the trust and confidence of patients and the public.

Sample Answer: An interdisciplinary theory integrates knowledge and concepts from one or more disciplines to enhance nursing practice, research, and education. General systems theory

is a conceptual framework that describes how systems function and interact with their environment, viewing the world as a network of interconnected systems. While both theories provide a holistic perspective on health care, general systems theory can help nurses and other healthcare professionals analyze the relationships and interdependencies within the overall system, identify patterns, and address underlying causes of problems, such as when a patient lives in a distressed area with issues such as poverty and excessive crime.
